1. **Licence.** The Author(s) hereby grant to NNM the non-exclusive, perpetual licence (the “**Licence**”) to copy, translate, publish and distribute the Work or portions of the Work in any printed or electronic form (collectively, the “**Publications**”) including on the Internet (including the NNM’s website), in newsletters, in television and radio programming, in reprints, compilations and anthologies and on any recorded media, whether in the past, present or future.
2. **Modifications.** NNM may edit or modify the Work as it considers appropriate, exercising its discretion in good faith. When it reproduces the Work, NNM will cause an appropriate credit acknowledging Author(s)'s authorship of the Work to appear in a location and manner that is in accordance with its customary practice.
3. **Use of Author’s Name, etc.** The Author(s) grant NNM the right to use Author(s)'s name, likeness and photograph in or on any of the Publications and in any advertisement or other publicity to promote the Publications. Except as otherwise provided herein, the Author(s) hereby waives any and all moral rights in the Work (i.e. allows editing by the NNM).
4. **Ownership.** As between the NNM and the author(s): the Author(s) own(s) the Work and all copyright and other proprietary rights in the Work, and NNM will own all copyright and other proprietary rights to the artwork and illustrations published with the Work, any compilations containing the Work, and any translations of the Work made by or for the NNM.
5. **No Royalties.** NNM will retain all revenues it receives from publishing the Work. NNM will not pay any royalties or other fees to the Author(s).
